#### COOPERATIVE AGREEMENT

For the purpose of educational and scientific cooperation and promotion of the culture:

Irkutsk National Research Technical University - Power Engineering Faculty (Irkutsk, Russia) and Wroclaw University of Science and Technology - Faculty of Electrical Engineering (Wroclaw, Poland), herewith stipulate this Agreement.

# ARTICLE 1 Areas of discipline

The parties intend to implement the activities in the areas of discipline as follows: electrical engineering, power system planning and operation, optimal power system control, power system protection, Smart Grid technologies, integration of renewable energy sources into the power system, information systems and technologies, mechatronics and robotics.

## ARTICLE 2 Staff exchange

The staff exchange is aimed at study promoting and research and teaching experiences.

The stay at the host institution will have duration of no more than 1 month, unless specifically agreed upon on the grounds of specific programs.

The teaching activities may be delivered in the areas indicated in the article 1 of the Agreement.

The number of the exchanges is fixed as follows: no more than 2 people per Institution no more than 4 people per year.

### ARTICLE 3 Student exchange

Postgraduate, graduate and undergraduate students shall be also included in the exchange. The exchange shall not exceed 10 months for 2 people per each study level and 6 people per year in the aggregate. Each home institution will carefully select nominees to participate in the exchange taking into account the average mark of examinations, the quality of the study and research project presented by the student.

In order to support the exchange student from the partner institution, each student is obliged to pay for the tuition and standard fees only to the home institution.

Incoming students' plan of study should be approved by both universities. The exams taken in the host universities will be recognized by the sending university as part of the regular study curriculum of the student.

# ARTICLE 4 Other forms of collaboration

Besides the fields of activities indicated above, the two parties intend to organize conferences, prepare publications and cultural events.

## ARTICLE 5 Financial aspects

This Agreement shall not entail any financial obligations for the parties. Particular forms of collaboration will be governed by the separate agreements.

As for the staff exchange, the two Institutions agree that the costs of travel, lodging and medical insurance are responsibility of the dispatching institution. Exchange faculty members will remain on their home institution's payroll. If the host university requires them to teach a structured module or a full course, then the exchange teacher shall be remunerated for the teaching by the host university.

As for the student mobility, each student is expected to pay for all of his/her travel expenses (domestic and foreign), housing, and meal plan or food at the host institution.

### **ARTICLE 6** Validity

This Agreement enters into force on the day of its signature and is concluded for 5 years. It may be renewed for a further five-year period by mutual written consent.

If the Parties, at least 6 months before expiration of this period, do not initiate to extend it, this Agreement terminates.

The Agreement may be terminated upon a prior three months written notice of termination, with effect at the end of the academic year.

All changes to this Agreement must be made in writing otherwise they are null and void.

## ARTICLE 7 Language of the Agreement

The present Agreement is drawn up in English in four copies. Each Party will receive two copies.
